SUBJECT:

City Council consideration of Resolution No. 2019-075 levying special taxes to be collected during Fiscal Year 2019-20 within Community Facilities District No. 2016-1 (Public Services).

RECOMMENDED ACTION:

That the City Council adopt Resolution No. 2019-075 levying special taxes to be collected during Fiscal Year 2019-20 for the payment of annual cost of public services within Community Facilities District No. 2016-1 (Public Services).

ANALYSIS:

It is necessary that the City Council levy special taxes for the payment of annual costs associated with police protection services, (including but not limited to criminal justice services), fire protection and suppression services, and paramedic services, within and in the surrounding area of Community Facilities District No. 2016-1 (the "District"), pursuant to Section 53340 of the Government Code. Special taxes within the District are levied in an amount necessary to satisfy the Special Tax Requirement, as defined in the District's Rate and Method of Apportionment (RMA). The special taxes levied will not exceed the authorized amounts as provided in the RMA.

COMMITTEE ACTION:

Not applicable.

STRATEGIC PLAN:

This item supports the City's Strategic Plan Goal 6: Improve Communications with Our Community; Objective a: Commit to transparency in all City actions. The recommended action will help achieve these goals by providing concise, forthright information regarding the annual special taxes that will be levied on each subject parcel within the District.

FISCAL IMPACT:

The following is a summary of the Fiscal Year 2019-20 budgeted revenues and expenditures for the District.

The recommended cost is necessary to provide police protection services, (including but not limited to criminal justice services), fire protection and suppression services, and paramedic services within the District throughout Fiscal Year 2019-20.

ENVIRONMENTAL ANALYSIS:

This action is exempt pursuant to Section 15061(b)(3) of the Guidelines for the California Environmental Quality Act (CEQA), which states that a project is exempt from CEQA if the activity is covered by the general rule that CEQA applies only to projects that have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the action is not subject to CEQA. This action merely sets the special taxes to be levied and collected within the District for Fiscal Year 2019-20, and there is no possibility that adopting the resolution will have a significant effect on the environment.


Community Facilities District No. 2016 - 1
Zone 1






Community Facilities District No. 2016 - 1
Zone 2







Community Facilities District No. 2016 - 1
Zone 3






Community Facilities District No. 2016 - 1
Zone 4











Zone 8













RESOLUTION NO. 2019-075

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CORONA, CALIFORNIA, LEVYING SPECIAL TAXES TO BE COLLECTED DURING FISCAL YEAR 2019-20 FOR THE PAYMENT OF ANNUAL COST OF PUBLIC SERVICES WITHIN COMMUNITY FACILITIES DISTRICT NO. 2016-1 (PUBLIC SERVICES)

WHEREAS, the City Council of the City of Corona (“City Council”) previously established Community Facilities District No. 2016-1 (Public Services) of the City of Corona, County of Riverside, State of California (the “District”) pursuant to the terms and provisions of the Mello-Roos Community Facilities Act of 1982, as amended, commencing with Government Code Section 53311 (“Act”) to levy special taxes for the payment of the annual cost of police protection services, (including but not limited to criminal justice services), fire protection and suppression services, and paramedic services (collectively “Public Services”), within the District and the surrounding area, and for the payment of administrative expenses incurred in connection with the levy and collection of said special taxes; and

WHEREAS, pursuant to Section 53340 of the Government Code, the City Council may by resolution provide for the levy of special taxes on parcels of taxable property in the District at a rate provided by ordinance or at a lower rate; and

WHEREAS, the City Council has previously levied special taxes on parcels of taxable property in the District by resolution, including Resolution No. 2018-078 adopted on July 18, 2018 that levied special taxes on such parcels for Fiscal Year 2018-19 Fiscal Year; and

WHEREAS, the special taxes will be levied for Fiscal Year 2019-20 on all parcels in each category of developed property in the District on the same basis and at the same rate to pay the annual costs of the Public Services within the District and in the surrounding area; and

WHEREAS, the rates of the special taxes that will be levied on such parcels for Fiscal Year 2019-20 will not exceed the rates previously approved by the qualified electors of the District.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Corona, California, as follows:

SECTION 1. Levy of Special Taxes. Special taxes shall be and are hereby levied for the Fiscal Year 2019-20 on all developed parcels of real property within the District that are subject to taxation, which are identified in Exhibit “A” attached hereto, and in the amount set forth for each such parcel in said Exhibit “A”. Pursuant to said Sections 53340 and 53358, such special taxes shall be collected in the same manner as ordinary ad valorem property taxes are collected

and shall be subject to the same penalties and the same procedure, sale, and lien priority in case of delinquency as is provided for ad valorem taxes.

SECTION 2. Transmittal to County. The City Clerk shall immediately following adoption of this resolution transmit a copy hereof to the Board of Supervisors and the County Auditor of the County of Riverside together with a request that the special taxes as levied hereby be collected on the tax bills for the parcels identified in Exhibit “A” hereto, along with the ordinary ad valorem property taxes to be levied on and collected from the owners of said parcels.
