RESOLUTION NO. 2023-051

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CORONA, CALIFORNIA, TO SPECIFY WHICH VOLUNTEER POSITIONS SHALL BE DEEMED TO BE EMPLOYEES OF THE CITY FOR THE SOLE PURPOSE OF PROVIDING WORKERS' COMPENSATION COVERAGE TO THE VOLUNTEERS WHEN THEY PERFORM SUCH VOLUNTEER SERVICE

WHEREAS, the City of Corona ("City") utilizes the services of unpaid volunteers within a number of its departments in a variety of capacities;

WHEREAS, some volunteers perform on-going City service roles for which staff believes it is in the best interest of the City and volunteers to provide workers' compensation coverage ("City Service Volunteers");

WHEREAS, Labor Code Section 3363.5 authorizes government agencies to adopt a resolution designating some or all of its volunteers to be employees for the sole purpose of California workers' compensation law;

WHEREAS, Section 3363. 5 of the Labor Code defines "voluntary service without pay" to include those services performed by any person who receives no remuneration other than meals, transportation, lodging or reimbursement for incidental expenses; and

WHEREAS, pursuant to Labor Code Section 3363.5, the City Council wishes to extend workers' compensation coverage, as provided by state law, to the City Service Volunteers designated in this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CORONA, CALIFORNIA, AS FOLLOWS:

SECTION 1. Those persons who perform voluntary service without pay in those City Service Volunteer positions designated in Exhibit "A" attached hereto and incorporated herein by reference shall be deemed to be employees of the City for the sole purpose of providing workers' compensation coverage as allowed under Labor Code Section 3363.5. This Resolution expressly does not make such volunteers an employee of the City for any other purpose, nor increase or expand any other right, duty or responsibility of a volunteer or of the City.

SECTION 2. The Mayor shall sign this Resolution and the City Clerk shall attest thereto, and this Resolution shall take effect and be in force on the date of its adoption.
