

RESOLUTION NO. 2024-003

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CORONA, CALIFORNIA, APPROVING A STREET NAME CHANGE WITHIN TRACT MAP 37644 GENERALLY LOCATED WEST OF BEDFORD CANYON ROAD AND NORTH OF HUDSON HOUSE DRIVE FROM SPRING LANE TO SPRING HAVEN LANE.

WHEREAS, Section 5026 of the California Streets & Highways Code authorizes the legislative body of a city to change the name of any street, boulevard, park, or place by adopting a resolution evidencing such name change; and

WHEREAS, on December 5, 2019, the City of Corona (“City”) approved the street name Spring Lane for a new residential subdivision created by Tract Map 37644;

WHEREAS, on January 15, 2020, the City Council at its regularly scheduled meeting, approved Tract Map 37644 for the subdivision of 51.15 acres into 45 numbered lots for the development of 490 residential condominium units, and 32 lettered lots totaling 4.83 acres for roadway, open space, and flood control purposes;

WHEREAS, on March 11, 2020, Tract Map 37644 was recorded at the Riverside County Recorder’s Office;

WHEREAS, on or around November 15, 2023, the City learned the street name Spring Lane already existed in the City prior to Tract Map 37644 and that the street name Spring Lane approved for Tract Map 37644 created two streets with the same name in the City;

WHEREAS, the City’s Public Safety Dispatch for the City’s Police and Fire Departments has determined that having two streets with the same name in the City poses a public health and safety concern because it could lead to a delay in providing emergency response to the properties on Spring Lane; and

WHEREAS, on January 17, 2024, the City Council at its regularly scheduled meeting approved changing the street name from “Spring Lane” to “Spring Haven Lane” within Tract Map 37644.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CORONA, CALIFORNIA, AS FOLLOWS:

SECTION 1. The City Council hereby renames the street "Spring Lane" within Tract 37644 to "Spring Haven Lane," as shown on Exhibit "A" attached hereto.

SECTION 2. The City Clerk shall forward a copy of this resolution to the Clerk of the Board of Supervisors of Riverside County and to the Riverside County Surveyor.
