1. Update of Sales Tax Information by HdL Companies.

Ken Brown, HdL Companies provided an update, Mr. Brown provided a presentation highlighting the 3rd Quarter 2022, Bradley-Burns Regional Report, Regional Comparison, City Comparison, City Comparison 1 Per Capita Adjusted Sales Tax Graph, City Comparison 2 Per Capita Adjusted Sales Tax Graph, Corona Major Industry Group Performance, Corona Majority Industry Groups (5 Largest), Corona Major Industry Groups (Remaining 3), Corona Long Term Sales Tax Trend, and Corona Measure X adjusted results.
