
## Development of an I-15 Corridor Lobbying Group

### The Ask...

That the City Council provide feedback on the proposed format of an I-15 corridor lobbying group or direct staff to no longer pursue this request.



### Background

- Future agenda item request from Council Member Wes Speake to:
  - Form a lobbying group of cities to support improvements to the I-15
  - Get Caltrans to formally recognize the effort and initiate a project
  - Go after regional, State, and federal funding
  - Complete the projects

### Background

- At its Fall Policy Workshop on October 12, 2023
  - Council gave direction to begin working on a lobbying group
  - Bring back to Council what it would look like

#### I-15 Lobbying Group Proposal

- City staff to schedule a meeting with elected representatives of communities along the I-15 corridor in Riverside County to be chaired by City of Corona Council Member
- Discuss projects and funding needs for projects on the I-15 corridor
- Write a joint letter to State and Federal elected representatives to lobby for future projects and funding opportunities for the I-15 corridor



## Riverside County Transportation Commission (I-15 projects in Corona)

- Interim Corridor Operations Project, use of shoulder lane for auxiliary lane, total project cost of \$5 million, construction completed in 2022
- I-15/SR 91 Express Lane Connector \$270 million Opened late 2023
- Corridor Operations Project between Cajalco to Weirick total project cost of \$21 million, construction complete in 2027
- I-15 Express Lane Southern Extension between Cajalco to SR-74, total project cost of \$650 million, construction to begin in 2026
- Feasibility study of smart freeway pilot project
- Included a I-15 rail project in RCTC's Traffic Relief Plan



## Caltrans projects on I-15 in Corona

- Re-stripe southbound I-15 at Cajalco to eliminate lane drop (EA 1N690)
  Cost estimate of \$1.1 million with construction to begin fall 2024
- Southbound deceleration lane from Old Temescal to Ontario (EA 1N610)
  Cost estimate of \$7.6 million, with construction to begin fall 2026
- Northbound auxiliary lane from Magnolia to SR-91 (EA 1P790)
  Cost estimate of \$10.2 million with construction to begin spring 2027
- Staff continue to partner with Caltrans to advocate for projects



## Federal, State, and Regional grants

- Eighty (\$80) million in new competitive grants since January 2021
  - o Federal: demonstration and discretionary from FHWA, FAA, and FHA
  - o State grants: beautification, maintenance, and safety from Caltrans, OTS, HBP
  - o Regional: roadways, storm drain, and ped safety from RCTC, RCFC, WRCOG
  - \$28 million since October 2023\*
- 2 years of supplemental staff through the I-REN program
- Not inclusive of formulaic grants (ARPA, Measure A, SB1-RMRA)
- Staff continue to go after future grants (SMART, ATP, BIP, RCE, RAISE)
- Partner with RCTC and WRCOG fund regional projects in Corona

## Options

#### City Council Options

#### Option #1

Direct City staff to form an I-15 lobbying group with the following agencies: Temecula, Lake Elsinore, Murrieta, Wildomar, Riverside County, Norco, Eastvale, Jurupa Valley

#### Option #2 (recommended)

Continue to advocate for Corona via state and federal lobbyists, annual meetings with federal/state representatives, and partnerships with Caltrans, RCTC WRCOG

#### **PROS**

- City of Corona can lead the discussion
- May influence Caltrans and RCTC to take initiatives on I-15 improvements

#### **CONS**

- Significant amount of staff time and effort to form the lobbying group
- May be difficult to get commitment or consensus from other agencies
- Other agencies may not have the resources (staff, funds, etc.) to participate
- Funding could go to other cities or areas instead of Corona

#### **PROS**


- Continued partnership and advocacy with Caltrans, RCTC & WRCOG for funding opportunities
- RCTC accelerated construction of the I-15 SB auxiliary lane from Cajalco to Weirick
- Caltrans initiated 3 projects on I-15: removal of lane drop, a deceleration lane, and auxiliary lane

#### **CONS**

 There is less strength in numbers for legislative or grant requests
