

**FIRST AMENDMENT TO
MEMORANDUM OF UNDERSTANDING FOR
COLLABORATIVE HOMELESS PROGRAMS AND SERVICES**

**BETWEEN THE CITY OF CORONA
AND
THE CITY OF NORCO
(FY 2023 FUNDS)**

1. PARTIES AND DATE.

This First Amendment to the Memorandum of Understanding for Collaborative Homeless Programs and Services ("First Amendment") is made and entered into this 21st day of June 2023 by and between the City of Corona ("Corona") and the City of Norco ("Norco"). Corona and Norco are sometimes individually referred to as "Party" and collectively as "Parties" in this First Amendment.

2. RECITALS.

2.1 MOU. Corona and Norco entered that certain Memorandum of Understanding for Collaborative Homeless Programs and Services ("MOU") for FY 2023 dated July 1, 2022 whereby Corona agreed to contract with City Net to provide homeless street outreach, engagement, case management, motel voucher emergency shelter, and Make It Cozy program services for Norco.

2.2 Amendment. Corona and Norco desire to amend the MOU for the first time to extend the term to June 30, 2024.

3. TERMS.

3.1 Term of MOU. Section 2 of the MOU is hereby deleted in its entirety and replaced with the following:

"The term of this MOU shall be from the Effective Date to June 30, 2024, unless earlier terminated as provided herein. The term of this MOU may be extended by mutual agreement of the Parties."

3.2 Continuing Effect of Agreement. Except as amended by this First Amendment, all provisions of the MOU shall remain unchanged and in full force and effect. From and after the date of this First Amendment, whenever the term "MOU" appears in the MOU, it shall mean the MOU as amended by this First Amendment.

3.3 Adequate Consideration. The Parties hereto irrevocably stipulate and agree that they have each received adequate and independent consideration for the performance of the obligations they have undertaken pursuant to this First Amendment.

3.4 Counterparts. This First Amendment may be executed in duplicate originals, each of which is deemed to be an original, but when taken together shall constitute but one and the same instrument.
