PROGRAM GOALS

The City of Corona's Canvas on the Curb Program ("Program") seeks to showcase local artists by transforming seven (7) City-owned traffic signal cabinets into public works of art. The goals of the Program are to build community, highlight the talent of Corona's artists, and enrich the community through displays of art that embodies Corona's rich diversity and history.

PROGRAM PROCESS

- 1. Artists will be required to submit a Canvas on the Curb Submission Form, signed waiver, and a picture or conceptual sketch of the artwork or planned design in the template provided. The artist will be required to identify three preferred locations for the installation of the artwork from the list of traffic signal locations provided on the Program website. The City retains sole authority to determine which, if any, artwork designs will be installed and the locations of where each selected artwork will be installed. There is no guarantee that the artist's artwork will be installed at any of the artist's preferred locations.
- 2. Art submissions will be reviewed by City staff and provided to the City Council for final approval. Make sure to review the Do's and Don't section before submitting your form.
- 3. Artists will be notified if their artwork has been selected for placement on a traffic signal cabinet. Artist will be required to sign an artist license agreement with the City. Each selected artist will receive a \$300 stipend. Upon request, artists shall provide their artwork to the City in a high-quality print-ready format.
- 4. The City will issue a call for sponsors to the public, inviting businesses, service organizations and the community to sponsor a piece of artwork with a \$1,300 donation.
- 5. The City of Corona will work with a contractor to digitize the selected artwork, if necessary, convert the selected artwork to a vinyl wrap, and install the selected artwork on a traffic signal cabinet.
- 6. Information on the artist and sponsor will be posted on the traffic signal cabinet in a 4" x 6" space on the sidewalk side of the cabinet, as well as

- the City's website. Additionally, all Program participants, including selected artists and sponsors, will be recognized at a City Council meeting.
- 7. The City of Corona is responsible for the maintenance of the cabinets. Any graffiti will be removed by the City at the City's expense. Artwork will be guaranteed to be installed for a one-year period. If the cabinet is damaged or replaced, artwork may be replaced after one year at the City's sole discretion and expense.

ARTIST ELIGIBILITY

The Program is open to all Corona residents that are:

- Professional artists;
- Amateur artists 16 years or older; and
- High school art, digital or graphic arts and photography teachers and their students (ages 16 and above).

To be considered for the Program, all artists shall complete and submit the submission form with basic information and a sketch (using the included template) of the artwork. The proposed artwork should cover all four sides and the top of the traffic signal cabinet. The artist will also be asked to provide a brief summary on why they'd like to be a part of the Program. All artists will be required to certify that they are the original creators of the artwork, sign a waiver and execute a license agreement allowing the City to utilize the artwork for installation on a traffic signal cabinet and for purposes of advertising the Program. The original art and all rights thereto will be retained by the artist.

Artists whose artwork is selected for the Program will be notified and will be asked to complete a W-9 Form in order to receive the stipend payment from the City of Corona.

ARTWORK GUIDELINES

All artwork will be digitized and used to create vinyl wraps that are applied to traffic signal cabinets owned by the City of Corona. Traffic signal cabinets may vary in size; see the submission form for the basic size. The vinyl wrap will be installed by a professional contractor and will contain a protective UV coating to reduce sun damage and allow for easy removal of graffiti.

The artwork design may not restrict any vents or airflow through the cabinets. If necessary, layout edits to the artwork may be required to ensure vents and airflow are not restricted. The City must be able to fully access the cabinet and the components and equipment inside the cabinet at all times. Any concrete bases shall not be included in the available area for art.

When artwork is placed on the City's traffic signal cabinets pursuant to the Program, the artwork constitutes City speech. By establishing the Program, the City does not intend to create any type of forum for private speech.

Artwork Do's and Don'ts

Do:

- Provide family-friendly artwork suitable for viewing by all ages.
- Use bright colors and images that can be visible from a distance.
- Consider incorporating Corona's heritage, events, landmarks, milestones, and images that highlight the local community and activities.
- Seek to build community, improve the quality of life and highlight Corona's cultural uniqueness.
- Create images of nature, inspiration, and beauty.
- Ensure that space. 4" x 6" in area, is available on the sidewalk side of your design for the placement of a plaque that recognizes both the artist and the sponsor. If no space is left, the City will select a spot on the sidewalk side of the box.
- Be original, creative and have fun. Artwork medium can be paint, pastels, digital, photography or just about anything that can be digitized and printed on vinyl wrap.

Don't:

- Use profanity or violent images.
- Advertise a business, political view or religion.
- Use a copyrighted or trademarked image.
- Defame or invade the rights of any person or group, living or dead.
- Leave any sides or top of the cabinet blank use the whole canvas.

HOW TO SUBMIT YOUR ARTWORK

Apply online at www.CoronaCA.gov. All submissions are due by October 19, 2022. All artists will be notified if their artwork has been selected or not.



Said section reads as follows:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASING PARTY.

INDEMNITY

As consideration for participating in the Event, Participant, on behalf of himself or herself and the Participant Releasors, hereby agrees to defend, indemnify and save and hold free and harmless the City Releasees from any and all liability from loss, damage, cost or injury, including wrongful death and including without limitation the payment of attorney's fees, to any property or persons, including third parties, in any manner arising out of or incident to any acts, omissions or willful misconduct of Participant or the Participant Releasors in any way related to participation in the Event. The Participant shall defend, at Participant's own expense, including attorneys' fees, the City Releasees in any action or proceeding, legal, administrative or otherwise, based on such acts, omissions or willful misconduct.

GENERAL PROVISIONS

Participant understands, acknowledges and agrees that: (1) Participant has read, understands and voluntarily signs this Release; (2) this Release is intended to be contractual and not a mere recital, shall be interpreted and applied as broad and inclusive as is permitted by federal, state and local laws, rules and regulations, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect; (3) valuable legal rights are being given up by executing this Release; (4) Participant has either had the assistance of legal counsel in the review of this Release or could have had such assistance and voluntarily declined to obtain such assistance; (5) this Release shall be binding upon the Participant and the Participant Releasors; (6) if any action at law or in equity, including an action for declaratory relief, is brought to enforce or interpret this Release, the prevailing party shall be entitled to recover such amount as the court may award as reasonable attorney's fees and costs; (7) this Release is the entire understanding with the City and no written or oral representations, statements or inducements, apart from the foregoing written provisions, have been made to induce Participant to execute this Release; and (8) Participant is representing that Participant is either age 18 or older, or has also had a parent or legal guardian execute this Release and accept full responsibility for all terms and conditions in this Release.

ARTIST LICENSE AGREEMENT FOR THE CITY OF CORONA CANVAS ON THE CURB PROGRAM [**INSERT ARTIST NAME**]

1. PARTIES AND DATE.

City and Artist are sometimes individually referred to as "Party" and collectively as "Parties" in this Agreement.

2. RECITALS.

- **2.1** The City has established the Canvas on the Curb Program ("Program") to highlight the talent of local artists and to enrich the community through displays of art on traffic signal cabinets that embody the City's rich diversity and history.
- **2.2** The Artist has been selected by the City Council to participate in the Program and will provide original artwork to be placed on City-owned traffic signal cabinet.
- **2.3** City and Artist desire to enter into this Agreement to set forth the terms and conditions for the City's use of the Artwork, as defined in Section 3.1.

3. TERMS.

3.1 Artwork.

- 3.1.1 <u>Originality</u>. Artist hereby represents and warrants that the artwork more particularly described and depicted in Exhibit "A" attached hereto and incorporated herein by reference ("Artwork") is an original work of art and that Artist is the author and creator of the Artwork. Artist shall defend, indemnify and hold the City, its directors, officials, officers, employees, volunteers and agents free and harmless for any alleged infringement of any patent, copyright, trade secret, trade name, trademark, or any other proprietary right of any person or entity in consequence of the use by City of the Artwork.
- 3.1.2 <u>License to Use Artwork</u>. Artist hereby grants to City an irrevocable license to use the Artwork and Artist's name, on the terms hereinafter set forth, for the purpose of installing the Artwork on a City-owned traffic signal cabinet and for use in promotion of the Program through print media, television and the internet, including, without limitation, various forms of social media. Artist agrees that City, without charge to City, may use the Artwork and make photographs or other reproductions of the Artwork without payment of royalty or other payment to Artist except as provided in Section 3.1.5.

- 3.1.3 <u>Program Guidelines</u>. Artist shall comply with all terms and conditions set forth in the Program Guidelines attached hereto as Exhibit "B" and incorporated herein by reference.
- 3.1.4 <u>Term</u>. The term of the irrevocable license granted herein shall commence upon the Effective Date of this Agreement and shall continue until such time that the Artwork is permanently removed from a City-owned traffic signal pursuant to Section 3.2.3.
- 3.1.5 <u>Stipend</u>. As consideration for Artist granting a license to the City to use the Artwork, the City shall pay to Artist a one-time stipend in the amount of Three Hundred Dollars (\$300.00) ("Stipend"). The City shall pay the Stipend to Artist upon receipt of the Artwork in final form and a completed Internal Revenue Service Form W-9, or equivalent.
- 3.1.6 <u>Waiver of Artist Rights</u>. Artist expressly acknowledges the provisions of and agrees to fully and completely waive any and all rights that Artist may have pursuant to Title 17 U.S.C. Section 101 at seq (commonly known as the "Visual Artists Rights Act of 1990"), pursuant to Section 987 *et seq* .of the California Civil Code (the "California Art Preservation Act"), or pursuant to any other law, statute, policy or regulation, to the extent any such right may exist in connection with the Artwork and to the extent that any such right conflicts with the license granted to the City pursuant to this Agreement.

3.2 City Obligations.

- 3.2.1 <u>Installation</u>. The City shall, at its cost and expense, cause the Artwork to be digitized, if necessary, converted to a vinyl wrap and installed on a traffic signal cabinet selected by the City.
- 3.2.2 <u>Maintenance</u>. The City shall, at its sole cost and expense, be responsible for the maintenance, repair, upkeep and replacement of the traffic signal cabinet, including without limitation, the removal of graffiti.
- 3.2.3 Removal or Replacement of Artwork. City may permanently remove the Artwork at any time; provided, however, that City and Artist understand that City intends for the Artwork to be on display for at least one (1) year. In the event the Artwork is permanently removed from a City-owned traffic signal, the City shall endeavor to provide written notice to the Artist. Notwithstanding the foregoing, Artist acknowledges and agrees that the City may replace or reinstall the Artwork in the event the traffic signal cabinet is damaged or replaced and/or in the event there is any damage or degradation to the Artwork and the irrevocable license granted herein shall continue to apply to the Artwork as replaced or reinstalled.

3.3 General Provisions.

3.3.1 <u>Authority to Enter Agreement</u>. The individuals signing below have full legal power and authority to sign for and bind the Artist to all obligations under this Agreement. There is no consent needed from any third Party for Artist to enter into this Agreement.
