The Ask

Should Resolution No. 2024-071 be approved to determine whether and in what amount Council Members may receive additional compensation for service on Joint Powers Authorities (JPAs) or other legislative bodies?

Ordinance 3397 Overview

Adopted May 1, 2024

- Establishes \$1,900/month Council pay (effective Jan 1, 2025)
- Authorized by SB 329 and GC Section 36516(A)

Ordinance Provision:

- Up to \$100/month additional pay for serving on JPAs
- Conditions:
 - Total compensation \leq \$2,550 (GC 36516(A))
 - No additional pay if JPA already compensates members

Additional Compensation:

- Requested by Council Member Speake
- For JPAs: Western Riverside County Regional Wastewater Authority (WRCRWA) and
- Research showed SB 329 and GC 36516(A) allow up to \$650/month



Ordinance 3397 Overview

Additional Compensation (continued):

- **Western Riverside County Regional Wastewater Authority (WRCRWA)**
 - Provides regional wastewater collection and treatment services
 - Five (5) Member Agencies/Board:
 - City of Corona
 - City of Norco
 - Home Gardens Sanitary
 - Jurupa Community District
 - Western Municipal Water District
 - Board Meetings: 5x annually
 - Approximately 13 full-time employees
 - Operating & labor budget of \$28.2 million
- **Bedford Coldwater Groundwater Sustainability Authority (BCGSA)**
 - Three (3) Member Agencies/Board:
 - City of Corona
 - Elsinore Valley Municipal Water District
 - Temescal Valley Water District
 - Board Meetings: 4x annually
 - 0 full-time employees (contracts services)
 - FY25 operating budget of \$684,325

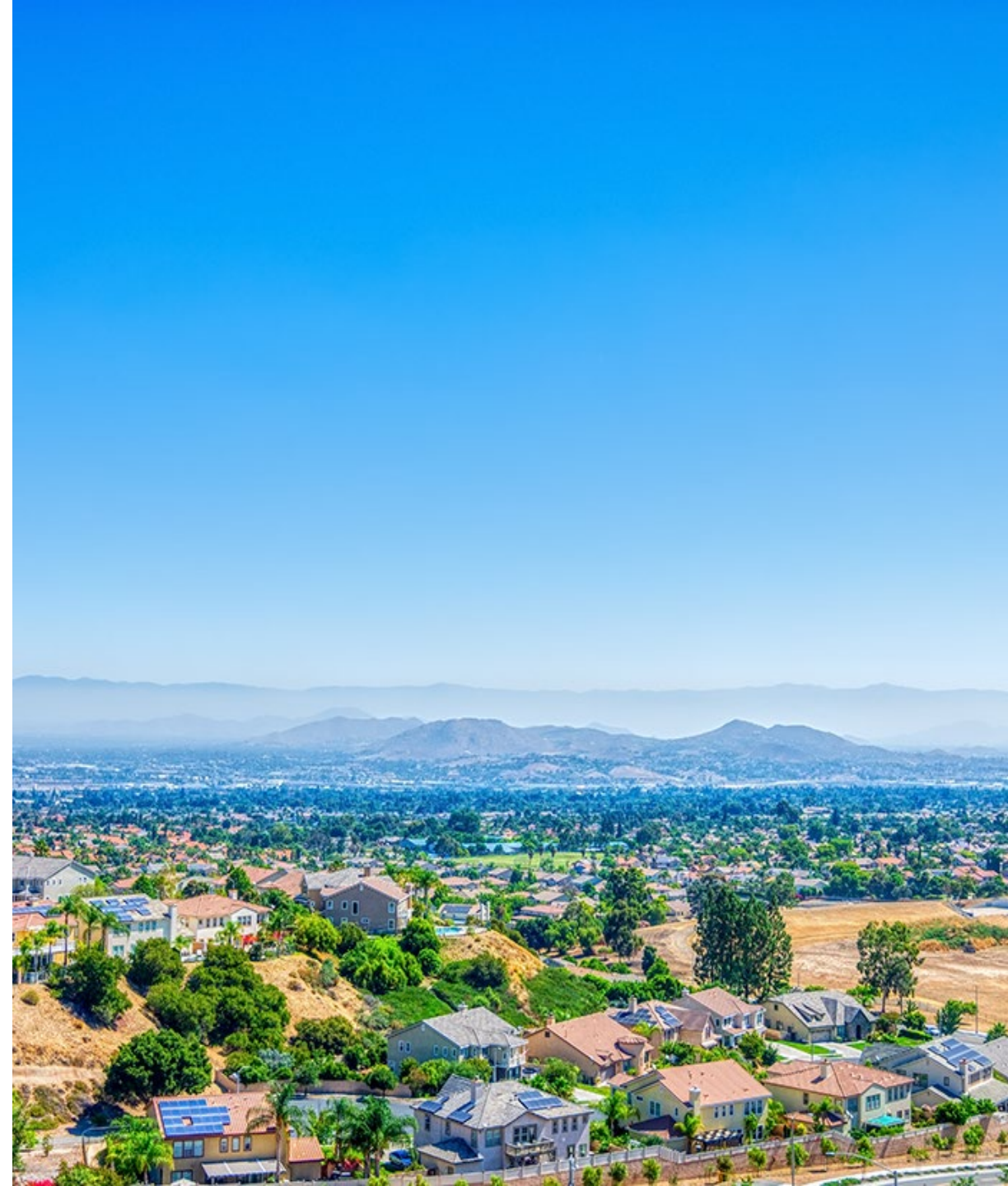
