Youth Sports Advisory Committee (YSAC)

- Formed in 2008 after review and approval by the Parks and Recreation Commission (Feb 13, 2008) and the City Council (March 5, 2008)
- Members must be a Corona-based non-profit sports group that have 75%
 Corona residency on the roster.
- 14 Leagues represent the following sports: Baseball, Football, Soccer, Softball, Swimming, and Tennis.
- Allocations for field space are conducted twice a year for Spring/Summer and Fall/Winter.

Surplus Field Allocation

Surplus Field Allocation

- Conducted Quarterly to allocate surplus field space to interested organizations who desire recurring reservations (two days per week for three months or more)
- Priority given to Corona-based non-profits with 75% participant residency

Surplus Field Users:

Field Usage Fees: \$10/hour per field (non-profit rate)

Lighting Fees: \$10/hour per field (flat rate)

- City Park
 - 2 Youth Soccer teams
- Citrus Park
 - 1 Flag Football League
 - 1 Lacrosse team
 - 1 Rugby team

* Pending – 1 baseball travel team

Individual Requests

Individual Requests

- Company softball games or team building events
- Typically 1 or 2 day reservations for a field
- Applicant submits field requests and we contact YSAC leagues regarding potential space if none is readily available.
- Individual Requests:
 - Field Usage Fees: \$30/hour per field (resident group rate)
 - Lighting Fees: \$10/hour per field
