THIRD AMENDMENT TO MAINTENANCE/GENERAL SERVICES AGREEMENT BETWEEN THE CITY OF CORONA AND

COME LAND MAINTENANCE CO., INC.

1. PARTIES AND DATE.

This Third Amendment to the Maintenance/General Services Agreement ("3rd Amendment") is made and entered into this 1st day of November, 2017 by and between the City of Corona ("City") and Come Land Maintenance Co., Inc., a Corporation ("Contractor"). City and Contractor are sometimes individually referred to as "Party" and collectively as "Parties" in this Third Amendment.

2. RECITALS.

- 2.1 <u>Agreement</u>. City and Contractor entered into that certain Maintenance/General Services Agreement dated July 15, 2016 ("Agreement"), whereby Contractor agreed to provide City-Wide Janitorial Services through December 31, 2016.
- 2.2 Prior Amendment(s). City and Contractor entered into that certain First Amendment to the Maintenance/General Services Agreement dated January 26, 2017 ("First Amendment") and that certain Second Amendment to the Maintenance/General Services Agreement dated July 1, 2017 ("Second Amendment").
- 2.3 <u>Amendment Purpose</u>. City and Contractor desire to amend the Agreement for the Third time to amend the Compensation through December 31, 2017.

3. TERMS.

- 3.1 Compensation. Section 3.3.1 (Compensation) of the Agreement, as amended by the First Amendment and the Second Amendment, is hereby deleted in its entirety and replaced with the following:
 - "3.3.1 Rates & Total Compensation. Contractor shall receive compensation, including authorized reimbursements, for all Services rendered under the Agreement at the rates set forth in Exhibit "C-2" attached hereto and incorporated herein by reference. The total compensation, including authorized reimbursements, shall not exceed Two Hundred Twenty Five Thousand Dollars (\$225,000) ("Total Compensation") without written approval of the City's Representative. Extra Work may be authorized, as described below, and if authorized, will be compensated at the rates and manner set forth in this Agreement."
- 3.2 <u>Continuing Effect of Agreement</u>. Except as amended by this Third Amendment, all provisions of the Agreement shall remain unchanged and in full force and effect.

From and after the date of this Third Amendment, whenever the term "Agreement" appears in the Agreement, it shall mean the Agreement as amended by this Third Amendment.

- 3.3 <u>Adequate Consideration</u>. The Parties hereto irrevocably stipulate and agree that they have each received adequate and independent consideration for the performance of the obligations they have undertaken pursuant to this Third Amendment.
- 3.4 <u>Counterparts.</u> This Third Amendment may be executed in duplicate originals, each of which is deemed to be an original, but when taken together shall constitute but one and the same instrument.
