

RESOLUTION NO. 2018-013

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CORONA, CALIFORNIA, AUTHORIZING THE PUBLIC WORKS DIRECTOR OR DESIGNEE TO EXECUTE AND FILE APPLICATIONS, FUNDING AGREEMENTS, REVISIONS, IF REQUIRED, AND ALL NECESSARY SUPPORTING DOCUMENTS FOR THE LOW CARBON TRANSIT OPERATIONS PROGRAM (LCTOP) WITH THE CALIFORNIA DEPARTMENT OF TRANSPORTATION

WHEREAS, California Legislature, Senate Bill 862 (SB 862), established Transit, Affordable Housing, and Sustainable Communities Program, and appropriated proceeds in the Greenhouse Gas Reduction Fund for the Low Carbon Transit Operations Program (LCTOP); and

WHEREAS, SB 862 designates administrative agency requirements, appropriates LCTOP funds, and assigns California Department of Transportation (Caltrans), in coordination with Air Resources Board (ARB) to establish the program guidelines; and

WHEREAS, SB 862 named the California Department of Transportation as the administrative agency for the LCTOP; and

WHEREAS, the City of Corona is an eligible recipient and may receive state funding from the LCTOP for transit projects; and

WHEREAS, the City of Corona will use Fiscal Year 2017-18 LCTOP funds in the amount of \$179,276 for operating assistance for the following projects: Expand bus service and a Free Fare Program; and

WHEREAS, LCTOP funds will benefit the City of Corona service area, including those areas identified as disadvantaged communities.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Corona, California, as follows:

SECTION 1. The Public Works Director or his/her designee is hereby authorized to execute and file applications, funding agreements, revisions, if required, and all necessary supporting documents including the Authorized Agent Form, and Certification and Assurances for the LCTOP Program with the California Department of Transportation.

SECTION 2. The City of Corona and its agents shall comply with the provisions, conditions, and requirements set forth in the Certification and Assurances, the Authorized Agent documents, and applicable statutes, regulations and guidelines for all LCTOP funded transit

projects.

SECTION 3. The City of Corona approves the execution of the Certification and Assurances Form and the Authorized Agent Form as required for LCTOP Program.

SECTION 4. The City of Corona authorizes the submittal of an allocation request to the Department of Transportation for Fiscal Year 2017-18 LCTOP funds for operating assistance in the amount of \$179,276, which includes a contribution in the amount of \$174,805 from Riverside County Transportation Commission. The funds will be utilized to expand Fixed Route services and to fund the Free Fare Program.
