

### How to Work Effectively With Your City Manager and Department Heads

### Addressing the Challenges of Housing Affordability

This panel discussion will focus on how cities can proactively remove local barriers to help spur much needed housing construction and increase housing supply. The discussion will also cover new state funding (SB 2, Atkins) for updating housing plans to streamline the approval process, and the possibility of an infusion of \$4 billion for numerous housing programs if the Veterans and Affordable Housing Bond passes in November 2018.

### Public Engagement for Trust: What Elected Officials Should Know

Elected leaders often hear about how public engagement can enhance trust and involvement in important policy-making. What does "public engagement" really mean? When should you engage residents? When should you not attempt it? What are leading techniques in civic engagement at the local level? Is it worth the effort? This session addresses these questions and promotes discussion of this emerging issue. Panelists are elected leaders and public engagement practitioners with a decade of experience. Get a basic grounding in this best practice and bring home new ideas for use on local issues of importance to your residents and businesses.
