6. ADMINISTRATIVE REPORTS

A. Park Updates

Mr. Moody reported on statistics for the month of May. There were 188 completed requests for tree trimming and 679 inches of tree removal. Staff responded to 154 graffiti requests. At the end of May, Ridgeline Park Splash Pad and Citrus Park Splash Pad were opened for the summer. The Citrus Park splash pad resurfacing project was completed at the end of May and a rededication ceremony was held on June 7, 2018. Miguel's Restaurants and the Vasquez family donated \$51,300 towards the project. A ribbon cutting event was held on May 5, 2018 at City Park for the opening of the new basketball and volleyball courts. At Border Park, four new pickleball courts were installed at a cost of approximately \$2,650. Staff continues to evaluate the cost to include pickleball lines to the existing tennis courts at El Cerrito Park.

B. Library and Recreation Services Updates

Ms. Schellberg provided an update on the Youth Sports Advisory Committee and reported that staff continues to work with the YSAC members on their field allocations and past due fees owed to the City. Staff continues to evaluate field maintenance costs and what the YSAC should pay for field use. The City is currently undergoing a fee study and staff is evaluating current fees to determine if adjustments are needed.

Ms. Schellberg announced the upcoming Library and Recreation Services summer events which include Summer Reading Program at the Library, Adventure Day Camp at Vicentia Activity Center and Auburndale Community Center, Aquatic Swim lessons, July 4th Celebration at Santana Park and Summer Concerts at City Hall beginning July 12th. New this year, the Summer Concerts are sponsored by the Corona Parks Foundation.

7. TRAILS SUBCOMMITTEE UPDATE

Ms. Wentworth reported the Trails Subcommittee is working with the City's IT department on an application to map data points for trails within the Corona area. The trails that they are accessing include hiking and bike trails.

It was decided to reach out to Commissioner Miller to see if he is able to attend and if he is not, the meeting will be cancelled.

9. COMMISSION MEMBER'S REPORTS AND COMMENTS

Commissioner Tressen announced he attended the Corona Rotary's Lobsterfest event held on the City Hall's south lawn. He highly recommended the venue for events and was pleased with how the event turned out.

Commissioner Shapiro thanked the Directors for their reports. He encouraged the public to attend the July 4th Independence Day Celebration at Santana Park and that non-profits will be selling food at the festival. He also announced the Community Health survey is due June 14th and encouraged the community to provide their input on creating a healthy community for the City's General Plan. A public meeting will be held on June 21st. from 6 p.m.-8 p.m. at the Circle City Center.

Vice Chair Almasy thanked the Directors for their reports and is looking forward to attending the July 4th Independence Day Celebration. He also announced that he was involved in forming a four-on- four Senior Basketball League that plays at the Circle City Center.

Chair Wentworth acknowledged the Corona Rotary's support of the July 4th Independence Day parade and is looking forward to attending the July 4th Celebration. Chair Wentworth announced the Trails Subcommittee will be held on July 9th at 6:30 p.m. at the Circle City Center. She also stated that the pickleball courts are working well and have been in use by the public. Lastly, she announced the Corona Parks Foundation is sponsoring the Summer Concerts series this year.
