

RESOLUTION NO. 2018-103

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CORONA DEDICATING THE BALLFIELD AT EAGLE GLEN PARK AS “REMEMBRANCE FIELD” AND AUTHORIZING THE PLACEMENT OF A PLAQUE NEAR THE FIELD COMMEMORATING MEMBERS OF THE CORONA COMMUNITY WHO LOST THEIR LIVES AT THE ROUTE 91 HARVEST MUSICAL FESTIVAL IN LAS VEGAS ON OCTOBER 1, 2017

WHEREAS, on October 1, 2017 the deadliest mass shooting in United States history occurred in Las Vegas at the Route 91 Harvest Musical Festival; a national tragedy with a significant community impact that took the lives of 58 people, including 4 members of the Corona community, and injured more than 800;

WHEREAS, the City Council would like to dedicate a space in the community for people to commemorate the victims of the tragedy, including the members of the Corona community who lost their lives during the tragedy;

WHEREAS, this dedication of the ballfield at Eagle Glen Park is outside the parameters of Administrative Policy 06400.0001 (City Property Naming Rights and Honorary Naming), since the ballfield will be dedicated as “Remembrance Field” and will not be named after an individual, family, business, non-profit organization, or other community group or organization as provided for in AP 06400.001 and

WHEREAS, while this dedication is outside of the parameters of AP 06400.001, it honors the City’s general criteria for naming City property, as referenced in Section 3.1(A) of AP 06400.001, because “Remembrance Field” will provide a location to commemorate members of the Corona community and thus over time will reflect Corona’s heritage, including its community members.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CORONA AS FOLLOWS:

SECTION 1. Dedication. The ballfield at Eagle Glen Park shall be dedicated as “Remembrance Field” and may be designated as such.

SECTION 2. Plaque. A plaque meeting the requirements provided for herein may be installed near the ballfield to designate “Remembrance Field” and to commemorate all those who lost their lives during the tragedy, including the following four Corona community members: Austin Davis, Thomas Day, Jr., Patricia Mestas, and Christopher Roybal. The size, design and location of the plaque shall be approved by the City Manager upon recommendation of the Director of Library and Recreation Services. All costs for the design, construction, installation and maintenance of the plaque shall be paid for by community donations and not with City funds. Additional names may be added to the plaque upon a determination by the City

Manager that a person not previously identified as having a connection to the Corona community does in fact have a demonstrable connection.

SECTION 3. Community Involvement. In addition to providing the plaque noted above, the City Council encourages members of the community to enhance Remembrance Field through the Honorary Dedication of Trees and Park Benches by means of the Park Memorial Program provided for in Section 3.1(B) of AP 06400.001.
