6. ADMINISTRATIVE REPORTS

A. Park Updates

Mr. Moody reported that in August, 446 trees were trimmed, 930 inches of tree roots were removed, and 106 graffiti reports were completed. There were 85 See Click Fix requests and 56 were closed. Mr. Moody announced that the Household Waste event will be held on October 13th and 14th in the parking lot at City Hall. Mr. Moody also reported that DWP is upgrading the reservoir at Mangular Park and adding a booster pump station. DWP has been working on this project over the past five years and recently held a community meeting. A project update will be provided to

the Parks and Recreation Commission at the November meeting.

Mr. Moody introduced Mr. Causey with Sprint Cellular. Mr. Causey reviewed the proposal to install a 45' cellular pine tower at Kellogg Park utilizing the existing equipment. Vice Chair Almasy asked who owns the building and Mr. Moody replied that the City does. The plans will be presented to the Planning Commission and then to be approved by the City Manager. Upon final approval, the plans will be presented to the City Council. The Parks and Recreation Commission had no objections to the proposal.

B. Library and Recreation Services Updates

Mr. Montgomery-Scott introduced the new Recreation Services Manger, Kristi McClure Huckaby. Ms. McClure Huckaby reported that 29 staff were recently hired for the fall programs. Flag Football will begin this fall and skills assessments will be held on September 15, 2018. Recreation Services has partnered with Southern California Municipal Athletic Federation (SCMAF) to train coaches and volunteers. The Senior Center Sock Hop event will be held on September 21, 2018 from 1 p.m.-3 p.m. The Kids Club after-school program is off to a great start and is offered at nine school sites.

Ms. Schellberg announced the ribbon cutting of the LARS On The Go program will be on September 26, 2018 at Citrus Park at 1 p.m and Star Wars Day will be held on September 22, 2018 from 10 a.m. to 1 p.m. at the Circle City Center. Ms. Schellberg reported that she attended the dedication of the Tom Wilson learning commons at Centennial High School.

Mr. Montgomery-Scott announced that the Remembrance Field dedication will be held at Eagle Glen Park at 10 a.m. on September 30th to honor the three Corona residents who lost their lives at the Route 91 concert .

Mr. Moody announced that staff is working on grafting the historic lemon tree at Joy Park and the grafting will occur on October 20, 2018.
