## Community Meeting Athletic Field Use Policy

#### Meeting minutes of March 28, 2019

The meeting was called to order at 6:30 p.m.

Ms. Schellberg and Mr. Lass presented an overview of the Field Allocation Policy and highlighted the field allocation process. The group was presented with six questions for open discussion and below is their feedback.

### Question 1: What is working for your group within the current policy?

- Liaison between the City & youth sports organization
- Recognize numerous recreation programs and opportunities
- Field maintenance communication
- Two-season field allocations: Spring & Fall
- Organizations coordinate field use for tournaments

### Question 2: What is not working for your group?

- Recreation youth sports groups versus competitive group and competitive groups field allocation is minimal
- Underutilized parks are not being used
- A clearly defined field allocation timeline needs to be developed
- Fields allocated but not being used so fields are unavailable for other groups to use
- Zero fields available so why try and apply
- Teams having to go to other cities to play
- Homeless and drug activity in the parks is a danger to players (PD/City Net)
- Accountability and enforce the current field allocation policy
- Non-resident numbers based off County areas
- Lack of parks with lights

### Question 3: What would you like to see for a more equitable experience?

- Fair allocation and distribution of fields
- Accountability of user groups
- Breakdown and identify games vs practice use

- Appropriate fee rate
- Clearly defined user group definitions
- Programs are accessible to youth
- Additional tiers within "non-profit" groups
- Defined inventory of resources
- Realistic permits times
- Challenger group is an exception to residency %
- Diversity of sport types
- Skill scale: beginner to advanced levels

## Question #4: What are your concerns regarding revising the policy?

- How will this impact my organization's future?
- Influx of new residents & population growth
- Balance between traditional and new sports organizations
- Maintenance of fields in relation to fees
- Umbrella organizations set boundary radius that local leagues must follow for registration with the City and/or school district
- "Open" registration and youth sports organization cannot turn anyone away
- Residency expectations for recreation vs travel/club
- Size of organization considered in allocation of space
- Safety at parks

# Question #5: What is a fair percentage of participation in a league?

- Consider size of organization when calculating residency percentages
- "Sphere of influence."" Umbrella organization has different boundary requirements and restrictions

# Question #6: Any other ideas for a successful policy?

- Sport groups to come together as a subgroup to review & discuss
- Keep the good players in Corona
- Provide options to review & match/combine
- Address subletting of fields
- Address residency requirements and boundaries
- Underutilized facilities...get them up to par to add additional resources/amenities

Commissioner Wentworth requested a park inventory list that highlights the underutilized parks that are not used for field allocation. The group will review a draft of the policy at the next meeting.
