REPLACEMENT CRITERIA / REASONS

- Equipment Age
 - End of lifecycle
 - 25 years typical
- No replacement parts available
- Surfacing installation / replacement for ADA accessibility



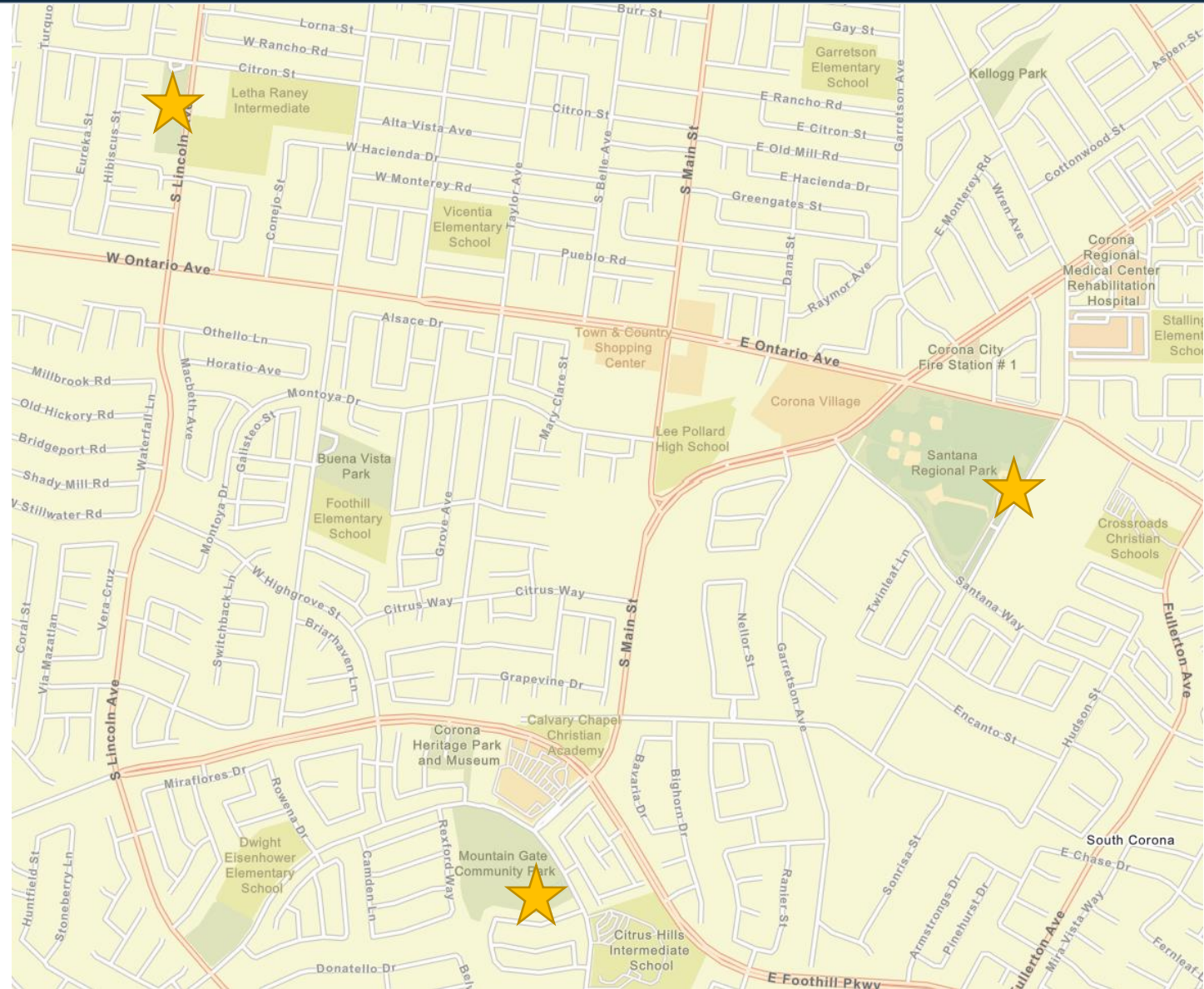
PLANNED & POTENTIAL LOCATIONS

Planned:

- Lincoln Park
 - Built in 1991
 - 34 years old
- Santana Park
 - Built in 1996
 - 23 years old
- Mountain Gate Park
 - Built in 1992
 - 27 years old
 - Requested funds in upcoming budget

Potential:

- Butterfield Park
- Tehachapi Park

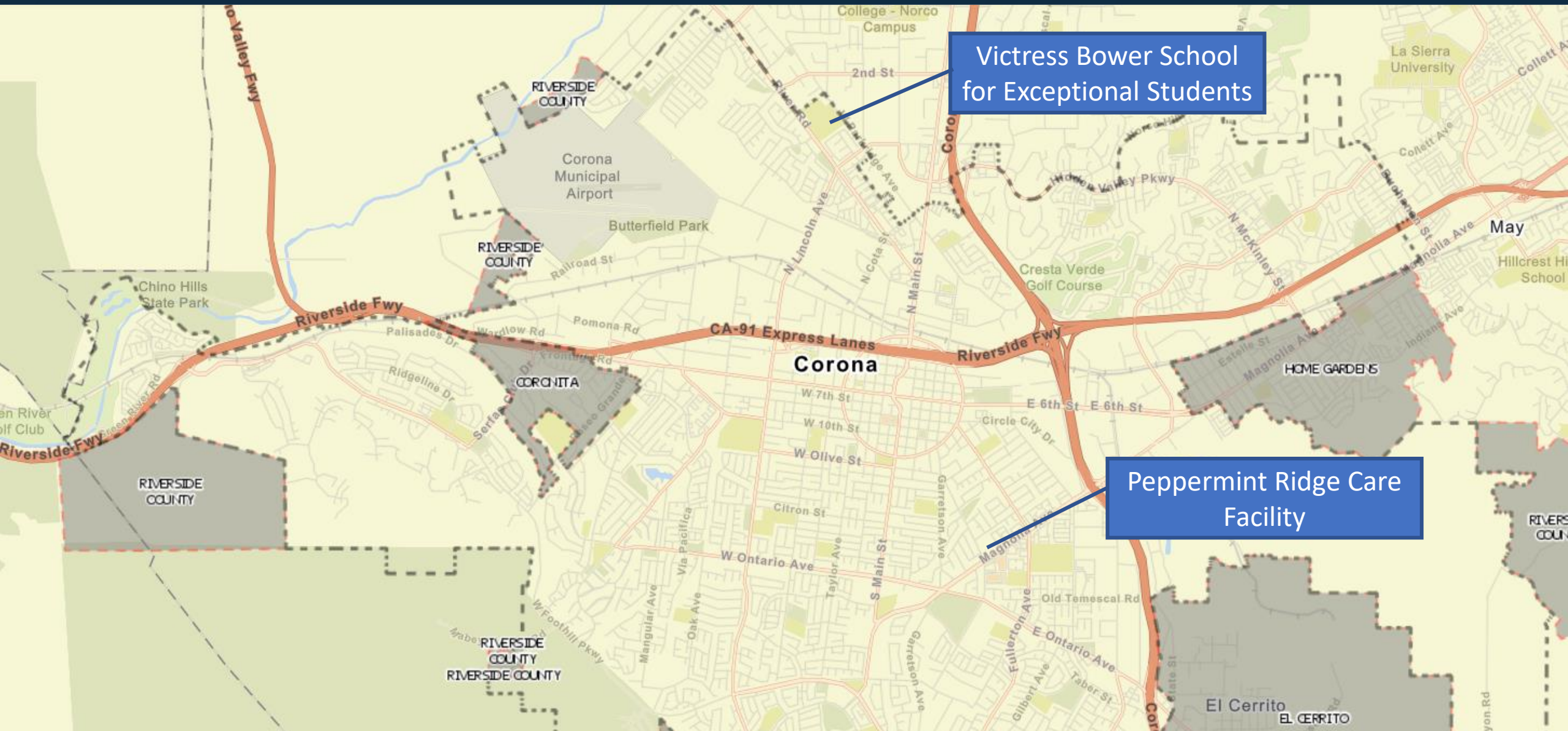


OPPORTUNITIES

- Corona Partners for Parks and Recreation
 - Fundraising for universal playground
 - Over \$55,000 raised to date
- Current and upcoming grants
 - NRPA / Disney – “Meet Me at the Park” Grant
 - Kompan – “Make Your Playground Bloom” Grant
 - State of California Proposition 68
- Van Daele Development
 - \$400,000 contribution
 - Stipulation for universal playground

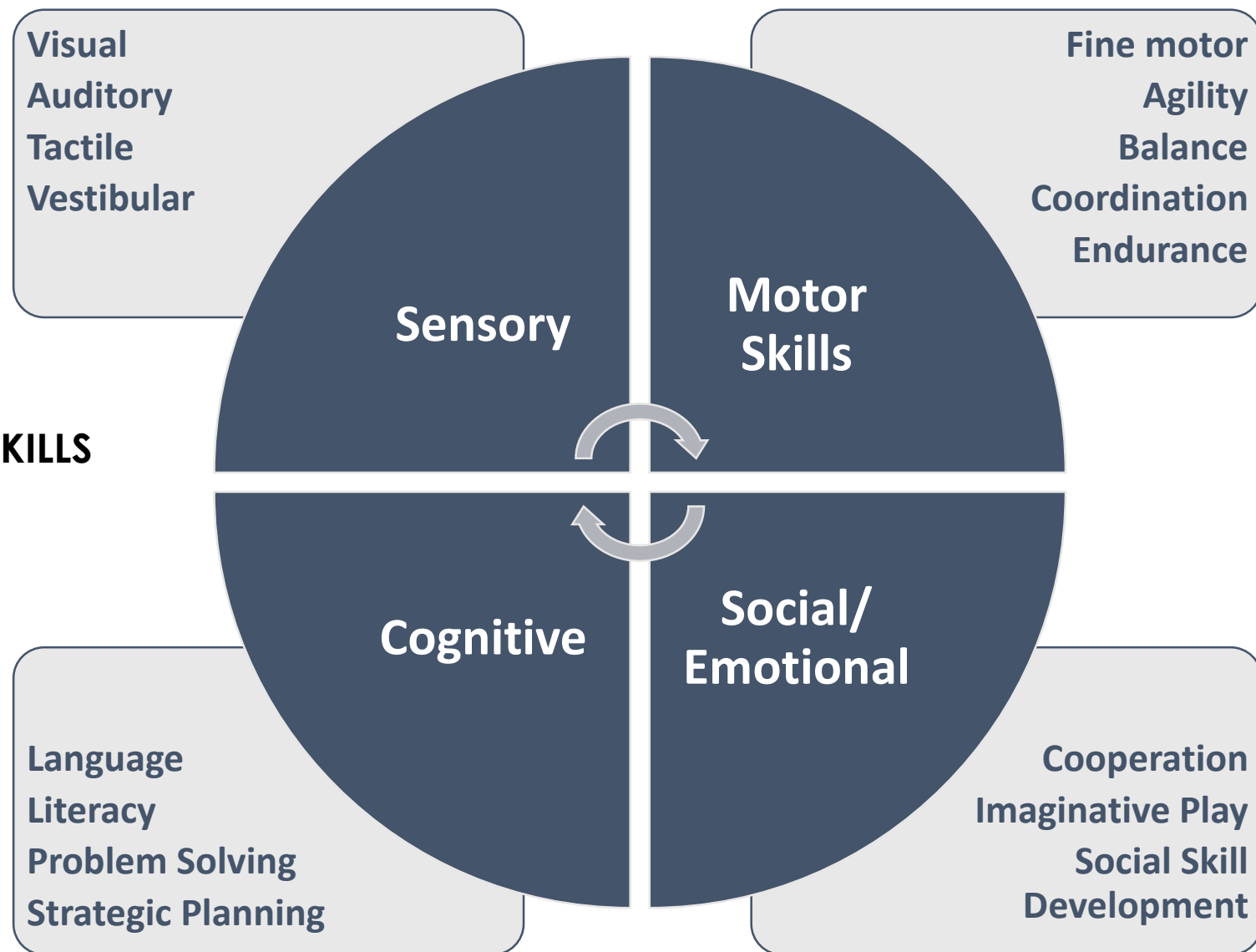

- Specialized or modified equipment

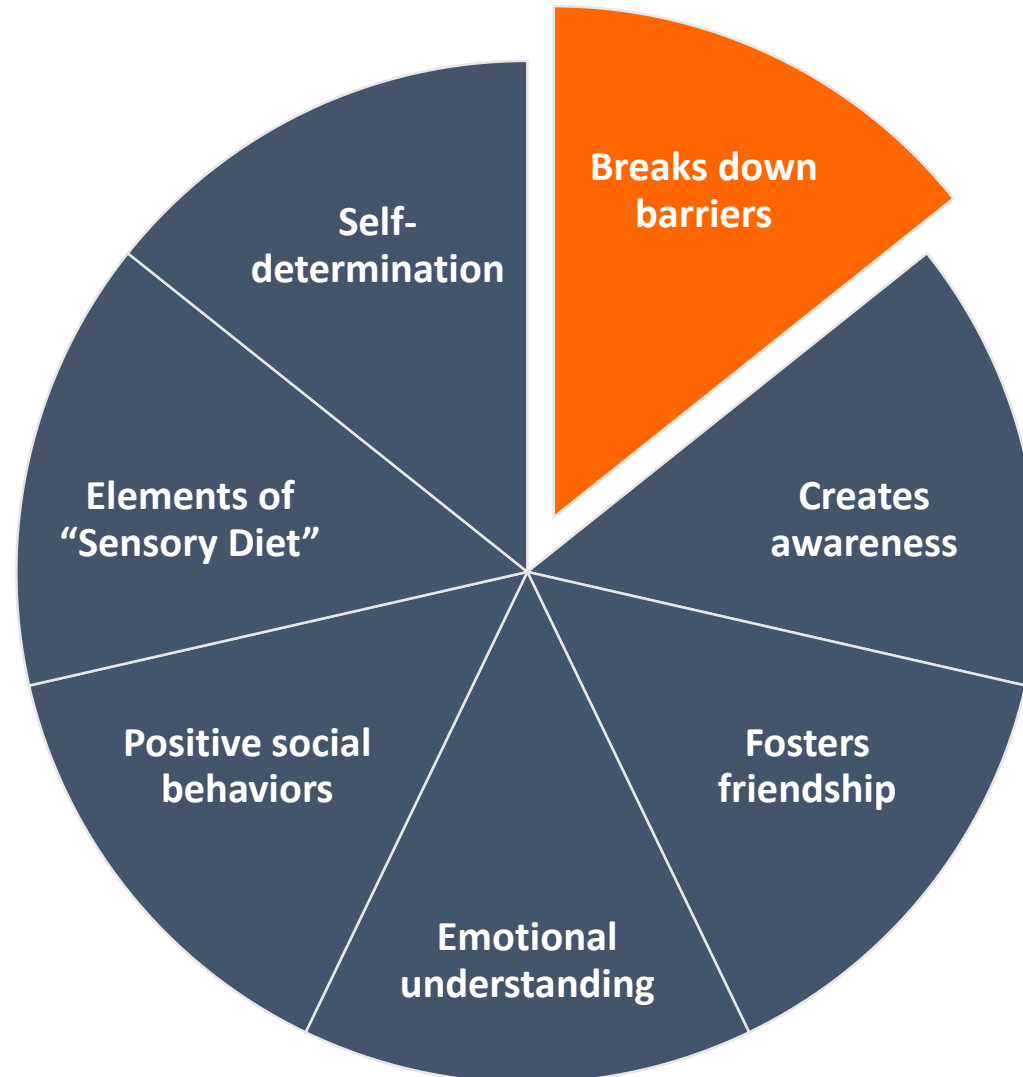


Inclusive

- Use of the same equipment and/or similar experiences in close proximity

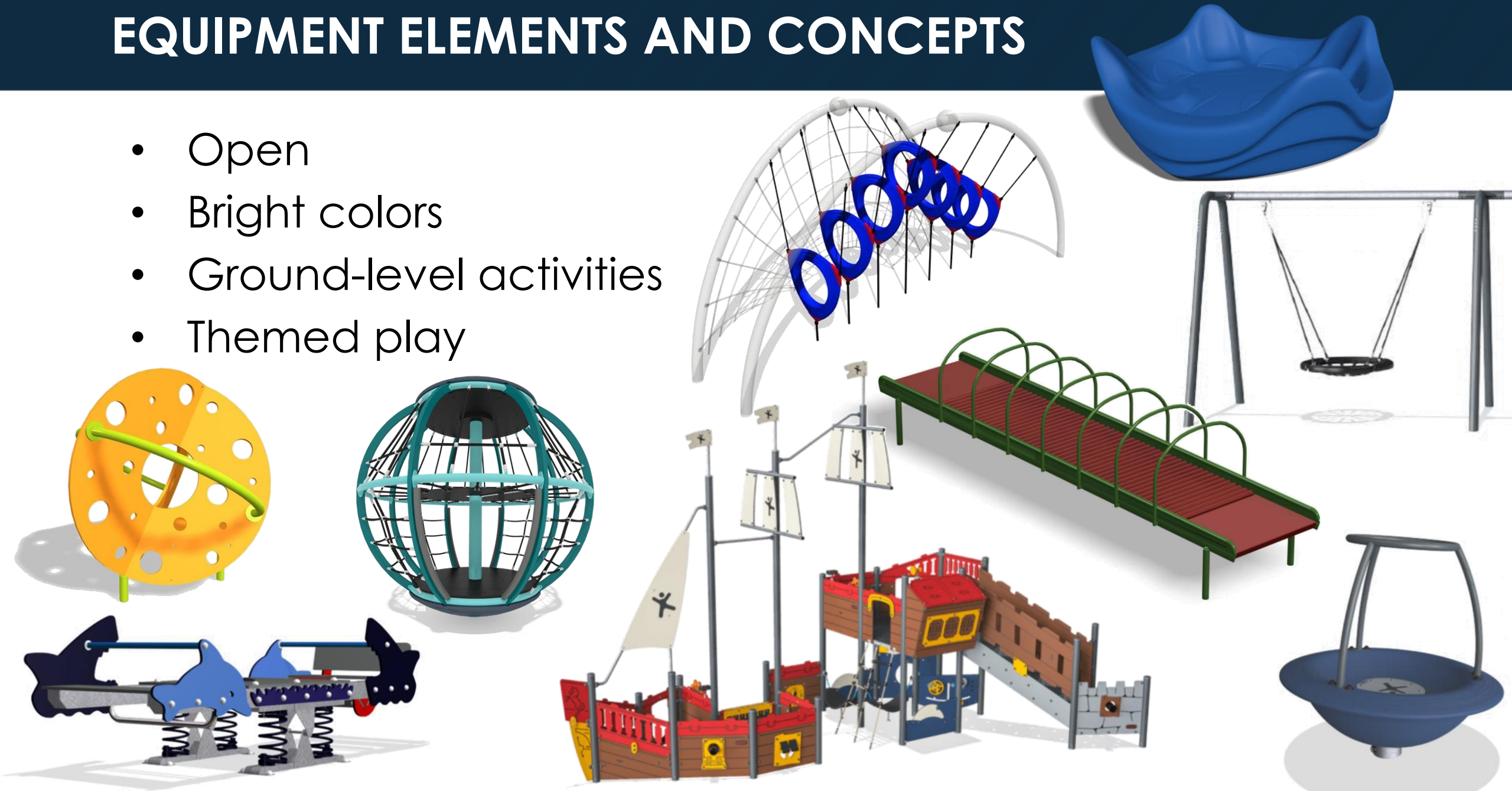


INCLUSIVE PLAY BENEFITS

PLAN FOR IMPLEMENTATION

- Conduct 1-2 charrettes for design and feature input
- Secure funding
 - FY 2019/20 Budget Process
 - **\$400,000 from Van Daele for Santana**
 - Requested \$200,000 for Lincoln Park
 - Grants:
 - **Awarded:** \$50,000 grant from Kompan – May 2019
 - Applied: \$30,000 grant from NRPA/Disney – June 2019
 - **\$50,000 donation from Corona Partners for Parks and Recreation**
- Finalize Design
- Construction – Fall 2019 to Spring 2020
