SUBJECT:

City Council consideration of acceptance and appropriation of \$110,000 from the Office of Traffic Safety 2019-2020 for the Selective Traffic Enforcement Program Federal Award.

RECOMMENDED ACTION:

That the City Council:

- 1. Accept the State of California Office of Traffic Safety 2019-2020 Selective Traffic Enforcement Program Federal Award of \$110,000 for Local Law Enforcement Agencies.
- 2. Appropriate \$110,000 of onetime money from the unappropriated General Fund Balance to be reimbursed from the State of California Office of Traffic Safety and increase the General Fund estimated revenue by the same amount for the program award.
- 3. Authorize the Chief of Police to execute any required grant documents that are in compliance with the City Council's actions hereunder.

ANALYSIS:

The Police Department has successfully applied for funding for the Selective Traffic Enforcement Program (STEP) for Local Law Enforcement Agencies.

The goal of the Selective Traffic Enforcement Program for Local Law Enforcement Agencies is to reduce the number of victims killed and injured in identified traffic safety problems in cities participating in the program.

Again, this year the Office of Traffic Safety combined various minor grants into the STEP program for program administration ease. Specific projects will address STEP priorities including: driving under the influence (DUI) saturation patrols, sobriety checkpoints, traffic safety education, distracted driving

enforcement, traffic enforcement including primary collision factors, bicycle and pedestrian enforcement, and motorcycle safety enforcement. The grant will provide support of these activities. In addition, the City of Corona's Police Department will participate and report data for various campaigns, such as the *Distracted Driving Awareness Month* in April, 2020 and participate in the statewide *Click It or Ticket* mobilization period in May, 2020.

Additionally, funding was awarded for the purchase of DUI checkpoint equipment and supplies, and for training costs. The approved training funding will allow four officers to attend standardized field sobriety testing (SFST) and Advanced Roadside Impaired Driving Enforcement (ARIDE) classes and one officer will be able to attend the Drug Recognition Expert (DRE) Recertification training.

The grant is a one-time award for General Fund reimbursement of equipment, designated training, and project overtime in support of the program. The grant performance period is October 1, 2019 to September 30, 2020.

This item supports the City Strategic Plan goal to Promote Public Safety: Protect our Residents and Businesses, (c) Ensure adequate funding for investments and improvement in infrastructure that support public safety.

Expenditures will be reimbursed to the General Fund following submission of the quarterly claims as estimated in that period. There is no cash match requirement. Any unused budget will carry forward into Fiscal Year 2020-2021.

These strategies are designed to earn media attention thus enhancing the overall deterrent effect.

1. PROBLEM STATEMENT

The City of Corona's population is at 167,843, per the United States Census 2017 estimated population, which is approximately a 10 percent increase since the 2010 U.S. Census. Since the year 2000, the population has increased about 30 percent, or about 43,000 residents. The population increase in Corona and surrounding communities has led to a rise in collisions involving vehicles, as well as, pedestrians throughout the City. A large reason for the population increase is due to the City of Corona being centrally located near and easily accessible through Interstate 15 and State Route 91. In addition, State Route 71 borders the City to the west. Citizens throughout Corona and communities to the east and south commute to and from Orange County, Los Angeles County, and San Bernardino County. This centralized location, combined with affordable housing, has made it very appealing to working class families with the median age being 33 according to the State of California, a decrease from 36 over the last few years. According to the United States Census Bureau, the City of Corona is ranked 4th in the United States and 2nd in California for the longest round-trip commute time, with an average of 36.7 minutes each way. The City of Corona also experiences pass-through traffic that utilizes the main corridor roadways to bypass the SR-91 and SR-15, which also contribute to the traffic issues. All the factors listed above have contributed to an increase in traffic congestion and not just during the morning and evening peak commute times.

In 2014, CALTRANS began a major improvement project to widen the 91 freeway where it passes through Corona. This project has now completed, but traffic issues remain as the regional population increase and subsequent commuter traffic is too much for the freeway to handle. In addition, Caltrans will be adding a lane of travel to the westbound SR-91 from Green River Road to the 241 toll road. This project will start in the end of 2019 into 2020 and will affect westbound morning commuters as well as streets in the city by diverted traffic that would normally travel on the freeway.

In 2017-2018 the I-15 widening project began in the City of Corona, which has and will continue to impact City streets. There has been closures at major on and off ramps and detours around the I-15 freeway.

Due to the continued construction and increase in commuter traffic, there has been an increase in wrong way drivers, distracted drivers utilizing social media apps, such as Google Maps and Waze, to cut through the city, and drivers not obeying traffic control devices and signs.

During the years of 2014 through 2018 Corona experienced 2,257 injury traffic collisions. (It should be noted that due to the calendar year 2018 just finishing, not all traffic collisions will have been entered into our database and this number will likely increase). From 2014 to 2018 Corona experienced 25 fatal traffic collisions. In 2016, there were 9 fatal collisions and 2017 and 2018 had 5 each.

Alcohol continues to be a problem with a majority of fatal collisions in the past 2 years being alcohol or drug related. Alcohol and drug related traffic collisions continue to be a significant matter in the City of Corona with DUI related collisions. There were over 1000 collisions between 2014 and 2018 where alcohol and/or drugs were involved, with about 284 causing injury and 23 fatalities.

Distracted driving has become an inherent problem throughout the nation. Cell phones and texting have become an increasing issue throughout the years for the City of Corona. There has been an increase in traffic collisions involving distracted drivers, attributing this as the primary collision factor, or as an associated factor in these collisions.

Pedestrian, bicycle, and motorcycle related collisions continue to be an issue in Corona. Between 2014-2018 there were 457 total collisions involving pedestrians (226), bicycles (150) and motorcycles (81). During the same time-period, injuries were sustained in 194 pedestrian, 120 bicycle, and 52 motorcycle collisions. There were 7 pedestrian fatalities, 1 bicycle fatality and 3 motorcycle fatalities. There was little change from the 2013-2017 average and in some cases slight improvement. Over the last three years there has been an increase in motorcycle collisions, and pedestrian/bicycle fatalities. The majority of Pedestrian and Bicycle fatalities in the last 5 years have occurred within the last three years.

3. METHOD OF PROCEDURE

A. Phase 1 - Program Preparation (1st Quarter of Grant Year)

- The department will develop operational plans to implement the "best practice" strategies outlined in the objectives section.
- All training needed to implement the program should be conducted this quarter.
- All grant related purchases needed to implement the program should be made this quarter.
- In order to develop/maintain the "Hot Sheets," research will be conducted to identify the "worst of the worst" repeat DUI offenders with a suspended or revoked license as a result of DUI convictions. The Hot Sheets may include the driver's name, last known address, DOB, description, current license status, and the number of times suspended or revoked for DUI. Hot Sheets should be updated and distributed to traffic and patrol officers at least monthly.
- Implementation of the STEP grant activities will be accomplished by deploying personnel at high collision locations. Media Requirements
- Issue a press release announcing the kick-off of the grant by November 15, but no earlier than October 1. If unable to meet the November 15 date, communicate reasons to your OTS Coordinator. The kick-off press releases and any related media advisories, alerts, and materials must be emailed for approval to the OTS Public Information Officer at pio@ots.ca.gov, and copied to your OTS Coordinator, 14 days prior to the issuance date of the release.

B. Phase 2 – Program Operations (Throughout Grant Year)

- The department will work to create media opportunities throughout the grant period to call attention to the innovative program strategies and outcomes. Media Requirements
- Send all grant-related activity press releases, media advisories, alerts and general public materials to the OTS Public Information Officer (PIO) at pio@ots.ca.gov, with a copy to your OTS Coordinator. The following requirements are for grant-related activities and are different from those regarding any grant kick-off release or announcement.
 - If an OTS-supplied, template-based press release is used, there is no need for pre-approval, however, the OTS PIO and Coordinator should be copied when at the same time as the release is distributed to the press.
 - If an OTS-supplied template is not used, or is substantially changed, a draft press release shall be sent to the OTS PIO for approval. Optimum lead-time would be 10 days prior to the release distribution date, but should be no less than 5 working days prior to the release distribution date.
 - Press releases reporting the immediate and time-valued results of grant activities such as
 enforcement operations are exempt from the recommended advance approval process, but still
 should be copied to the OTS PIO and Coordinator when the release is distributed to the press.
 - Activities such as warrant or probation sweeps and court stings that could be compromised by advanced publicity are exempt from pre-publicity, but are encouraged to offer embargoed media coverage and to report the results.
- Use the following standard language in all press, media, and printed materials: Funding for this program
 was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic
 Safety Administration.
- Email the OTS PIO at <u>pio@ots.ca.gov</u> and copy your OTS Coordinator at least 30 days in advance, a short description of any significant grant-related traffic safety event or program so OTS has sufficient notice to arrange for attendance and/or participation in the event.
- Submit a draft or rough-cut of all printed or recorded material (brochures, posters, scripts, artwork, trailer graphics, etc.) to the OTS PIO at pio@ots.ca.gov and copy your OTS Coordinator for approval 14 days prior to the production or duplication.
- Space permitting, include the OTS logo, on grant-funded print materials; consult your OTS Coordinator for specifics and format-appropriate logos.

C. Phase 3 - Data Collection & Reporting (Throughout Grant Year)

- Invoice Claims (due January 30, April 30, July 30, and October 30)
- Quarterly Performance Reports (due January 30, April 30, July 30, and October 30)
 - Collect and report quarterly, appropriate data that supports the progress of goals and objectives.
 - Provide a brief list of activity conducted, procurement of grant-funded items, and significant media activities. Include status of grant-funded personnel, status of contracts, challenges, or special accomplishments.
 - Provide a brief summary of quarterly accomplishments and explanations for objectives not completed or plans for upcoming activities.
 - Collect, analyze and report statistical data relating to the grant goals and objectives.

4. METHOD OF EVALUATION

Using the data compiled during the grant, the Grant Director will complete the "Final Evaluation" section in the fourth/final Quarterly Performance Report (QPR). The Final Evaluation should provide a brief summary of the grant's accomplishments, challenges and significant activities. This narrative should also include whether goals and objectives were met, exceeded, or an explanation of why objectives were not completed.

5. ADMINISTRATIVE SUPPORT

This program has full administrative support, and every effort will be made to continue the grant activities after grant conclusion.
