1. PROBLEM STATEMENT The Corona Police Department implemented the Crossroads electronic collision database system in early 2019 in order to facilitate the timely completion and review of traffic collision reports. However, the Corona Police Department Records Division has continued to batch, print, and ship collision reports to the California Highway Patrol SWITRS program on a monthly basis, which decreases the efficiency of the electronic collision database system and delays traffic safety data reporting. By implementing a solution to electronically submit Crossroads collision data to the California Highway Patrol SWITRS program, the Corona Police Department could increase their contribution to the Office of Traffic Safety's goal. This would help improve overall roadway safety, by providing accurate and timely data that roadway safety engineering improvements and traffic safety enforcement operations rely on.

Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion -- Lower Tier Covered Transactions:

1. The prospective lower tier participant certifies, by submission of this proposal, that neither it nor its principals is presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participating in covered transactions by any Federal department or agency.

2. Where the prospective lower tier participant is unable to certify to any of the statements in this certification, such prospective participant shall attach an explanation to this proposal.

BUY AMERICA ACT

(applies to subrecipients as well as States)

The State and each subrecipient will comply with the Buy America requirement (23 U.S.C. 313) when purchasing items using Federal funds.
