RESOLUTION NO. 2021-037

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CORONA, CALIFORNIA, AUTHORIZING THE CITY MANAGER, OR HIS DESIGNEE, TO RECEIVE AND ACCEPT SENATE BILL-1 ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017 REVENUE FOR FISCAL YEAR 2022 IN AN ESTIMATED AMOUNT OF \$3,285,482, FOR THE ELIGIBLE FISCAL YEAR 2022 ANNUAL STREET PAVEMENT REHABILITATION PROJECT, NO. 2021-03.

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and Signed into law by the Governor in April 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of our City of Corona are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

WHEREAS, the City of Corona must adopt by resolution a list of projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the City of Corona, will receive an estimated \$3,285,482 in RMRA funding in Fiscal Year 2022 from SB 1; and

WHEREAS, this is the fifth year in which the City of Corona is receiving SB 1 funding and will enable the City of Corona to continue essential road maintenance and rehabilitation projects, safety improvements, repairing and replacing aging bridges, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and

WHEREAS, the City of Corona has undergone a robust public process to ensure public input into our community's transportation priorities/the project list; and

WHEREAS, the City of Corona used a Pavement Management System to develop the SB 1 project list to ensure revenues are being used on the most high-priority and cost-effective projects that also meet the communities priorities for transportation investment; and

WHEREAS, the funding from SB 1 will help the City of Corona maintain and rehabilitate streets/roads, add active transportation infrastructure throughout the City of Corona this year and similar projects into the future; and

WHEREAS, the 2018 California Statewide Local Streets and Roads Needs Assessment found that the City of Corona's streets and roads are in an "good" condition and this revenue will help us increase the overall quality of our road system and over the next decade will bring our streets and roads into an "excellent" condition; and

WHEREAS, the SB 1 project list and overall investment in our local streets and roads infrastructure with a focus on basic maintenance and safety, investing in complete streets infrastructure, and using cutting-edge technology, materials and practices, will have significant positive co-benefits statewide.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CORONA, CALIFORNIA, AS FOLLOWS:

SECTION 1. The City Council hereby authorizes the City Manager to receive and accept Senate Bill-1 (SB1) Road Repair & Accountability Act of 2017 revenue for Fiscal Year 2022 in an estimated amount of \$3,285,482 for the eligible Fiscal Year 2021-22 Annual Street Pavement Rehabilitation Project, No. 2021-03, as such projects are further described in Exhibit "A" attached hereto and incorporated herein by reference.
