ARPA Status

 Interim Final Rule issued by US Dept. of Treasury May 2021

https://home.treasury.gov/policy-issues/coronavirus/assistance-for-state-local-and-tribal-governments/state-and-local-fiscal-recovery-funds

- Accepting input from agencies, due by July 16, 2021
- Final guidelines anticipated by end of July 2021 (original)
 - Revised guidelines to be released in the fall
 - Interim Final Rule is effective and binding until final rule adopted

ARPA Status

- \$1.9 Trillion Total
- \$350 Billion to states and local governments
- City of Corona Allocation: \$29,158,725
 - 2 installments: approx. July 2021 and July 2022
