C. <u>17-1238</u> Presentation: Assembly Member Sabrina Cervantes Legislative Update

Assembly Member Sabrina Cervantes provided a legislative update and commended Kimberly Davidson, Economic Development Manager for working together to bring local business concerns to the forefront.

**D.** 17-1241 Presentation: Public Works Department Traffic Update

Nelson Nelson, Public Works Director, provided an update on the current traffic issues within the City of Corona.

Sol Shapiro addressed the Council regarding traffic in the Green River area.

Sharon Carriedo addressed the Council regarding car pool lanes versus paid toll lanes and stated bridge construction is going to impact traffic in the Eagle Glen area. She requested signage to notify the drivers who might not live in the area.

Matt Olson addressed the Council to ask for clarification from the presentation and also requested the creation of a Task Force similar to the prior 91 task force.

Joe Morgan addressed the Council to state the school district was not a partner in this project and was not aware of any of the closures.

Stan Hill addressed the Council regarding traffic in the area of the Mountain View Civic Association, noting in addition to the areas listed in the

presentation as congested areas it is also congested on other streets such as Frontage Road and Paseo Grande which creates a safety hazard. He stated wider roads are not always the answer, the growth of the community needs to be analyzed in the way of a moratorium on new projects.

Don Fuller addressed the Council regarding the traffic, stating the 91 improvements project did not improve traffic at all.

Presentation: Department of Water and Power - SCE Power Outages Update

Tom Moody, Department of Water and Power General Manager, provided an update on recent power outages in the Dos Lagos area.

Christopher Abel, Principle Manager of External Affairs from Southern California Edison addressed the Council to discuss its commitment to working with Department of Water and Power to solve outage issues.

Mike Lewis, District Manager of SCE, addressed the Council to discuss why some areas of Corona experience outages more than others.

Brian Watkins, Engineering Manager from SCE, addressed the Council to discuss the plan to automate the problematic circuit.

Don Fuller addressed the Council regarding the outages.

Matt Olsen addressed the Council to inquire why the City is in the utility business; what is the benefit to residents.

Sharon Carriedo addressed the Council to state as a resident of Eagle Glen she does not experience many outages, yet Dos Lagos and The Crossings experience many outages and they are a newer area. She inquired what line the new development is going to be on and suggested being proactive with new development.

Michelle Wentworth addressed the Council to inquire about redundancy in the system.

Tom Richens addressed the Council to discuss the impacts of accepting contributions from developers on power outages.

Joe Morgan addressed the Council to ask what it takes to spring into action as the City is heading towards crisis.

Josh Goddard addressed the Council to state this issue is compounded by capitalism, we must battle private industry to provide public utilities.

Dale Pluong addressed traffic issues in his area, stating the 91 freeway project has not improved traffic in the area. He discussed ongoing issues with Oxbow's intention to develop the Mountain View Golf Course area.

Joe Morgan addressed the Council to state recent Council action delegated authority of cell phone tower approvals to the City Manager which was a misrepresentation of the types of Cell Towers that would be approved moving forward.

Council Member Randy Fox expressed his disappointment with the speakers insulting comments.

Matt Olsen addressed the Council regarding the traffic at the Green River Promenade.

Tom Richens addressed the Council to state if its not good for the citizens its not good for the City.

Josh Wagner, City employee, addressed the Council to discuss the salary reported on Transparent California differs from his actual paychecks.

Matt Woody addressed the Council to introduce himself as a candidate for Congress.

Josh Goddard addressed the Council regarding the lack of substantive information provided in the monthly Economic Development report. He suggested a moratorium on new projects.

Michelle Wentworth addressed the Council regarding the traffic around Green River, asking if traffic studies will now be done to see if the project was successful.

Don Fuller addressed the Council in support of Assemblymember Cervantes and Michelle Wentworth. He discussed the pastor who offered a Christian prayer and then left.
