At the request of Vice Chair Jones, Harald Luna, Associate Planner, reviewed the staff report for CUP2017-0104. At the conclusion of his presentation, Mr. Luna offered to answer any questions of the Commission.

Commissioner Ruscigno asked if there is sufficient parking spaces for the church to use.

Mr. Luna stated yes there is.

Commissioner Norton asked if there was a history of the church conducting church services in that location for a while.

Vice Chair Jones asked what the previous use was in that lease space.

Mr. Luna stated the church was allowed to use the space for office use in the meantime, until the approval of the conditional use permit to conduct actual church services.

Ms. Coletta stated the church is currently working on a change of occupancy approval. The church has been conducting Bible study, but tonight's proposal is for the approval of church services.

Vice Chair Jones opened the public hearing.

JOSHUA LEE, REPRESENTING JESUS BAPTIST U.S.A. CONFERENCE CORONA BAPTIST CHURCH, gave a brief overview of

the church's operations, its history, its membership, and goals to operate as good neighbors.

CHRISTI CALDIN, REPRESENTING AQUATIC ZONE, stated they are not opposed to the business, but the concern is the parking and hours of operation of the proposed church services. Ms. Caldin stated that historically, there have been issues with the parking during various hours.

Discussion ensued among the Commissioners and Mr. Lee regarding rights to the parking lot, potential growth of membership, and the need to adhere to the proposed hours of operations.

Vice Chair Jones closed the public hearing.

A motion was made by Ruscigno, seconded by Norton, that the Planning and Housing Commission adopt Resolution No. 2509 GRANTING CUP2017-0104, based on the findings contained in the staff report, the conditions of approval, and the added condition of approval presented to the Commission at the dais.
