## 16. CITY COUNCIL MEMBER COMMENTS

- A. Council Member Randy Fox

Council Member Fox commended staff for their hard work during the 4th of July celebration and provided highlights on the celebration. He



commended the noon Rotary Club for their sponsorship of the parade. He suggested putting rotary at the beginning of the parade. He noted that housing is what brought him to Corona and appreciates homeownership. He discussed the complexity of buying a lot and building a home and noted that developers fill a need in the City. He expressed appreciation for development of housing and noted that he has heard from homeowners and renters wanting to be homeowners.

B. Council Member Dick Haley

Council Member Haley commended staff for the 4th of July celebration. He thanked the Yard Sale band for their entertainment and noted that they are a local band. He gave kudos to the Public Works employee for controlling traffic signals during the 4th of July celebration. He announced that he will not be at the July 18, 2018 City Council meeting. He also announced that his son Eric will be discharged from the Army after 20 years of service on July 24th.

C. Council Member Jason Scott

Council Member Scott responded to comments made regarding the Chuck Wagon and noted that the owner of the Chuck Wagon had the business for sale for years and no one came forward to buy it. He also responded to Oxbow members who spoke and suggested that they contact their leadership. He commended the noon Rotary Club for their sponsorship of the 4th of July parade. He also commended City staff, David Montgomery-Scott, and Library and Recreation staff for their work and dedication on the 4th of July celebration. He noted that his family travels from northern California to Corona to attend the 4th of July celebration.

D. Vice Mayor Eugene Montanez

Vice Mayor Montanez commended the noon Rotary Club for their 4th of July sponsorship. He also commended the streets department for cleaning up after the Police Department's horses during the 4th of July parade. He expressed positive comments on the firework show and the variety of fireworks used. He provided clarification on the Oxbow project and noted that 90% of the property is in the County. He noted that he met with the developer about 2 years ago and asked them to work with the residents. He also noted that to his knowledge Specific Plans for the project have not been presented to the County and nothing has been decided on the City side.

E. Mayor Karen Spiegel

Mayor Spiegel commented on the Oxbow project and stated that she would

be willing to reach out to Oxbow for an update. She announced the upcoming Election Information meeting was scheduled to be held on Wednesday, July 11, 2018 in the City Clerk's office. She provided an update on Healthy Corona and invited residents to attend an upcoming meeting. She announced the three Cooling Centers that will be open due to the upcoming heat wave. She asked residents to keep an eye out for seniors and children in their neighborhood. She announced the upcoming events: Concerts on the Green at the City Hall South Lawn scheduled for July 12, 19, and 26 and August 2, 2018; Rockin' Summer Concerts at Dos Lagos scheduled for Friday nights; Christian Arts and Theatre presents "Little Women" at Historic Civic Center Theater on July 27 and July 28; State of the City on July 20 at Eagle Glen Golf Club and July 25 at City Hall. Mayor Spiegel asked Fire Chief Cox to provide an overview of pool safety. She also thanked all City departments for their service during the 4th of July celebration.
