5. REPORTS FROM SUPPORT GROUP LIAISONS & THE CITY

A. Friends of the Corona Public Library/Kathy Wright, President

Kathy Wright, President, Friends of the Corona Public Library, reported that the Friends made 18.4% more money than expected last year. They signed up 78 new members. Membership renewals are still strong. They made \$100,000 in bookshop sales and \$22,000 in internet sales. They made a total of \$138,000 in income. Adopt-A-Book paid for 333 books for the library. They did not push the Legacy Path Bricks last year. They are going to talk about doing something else. Ladders & Linguine was very successfull. They received grants from Larry H. Miller and All American Asphalt. They will be having a 6th annual crime authors luncheon. Purse-a-Palooza will be November 10th. They will have their Holiday Music Series again this year. February 21st will be Ladders and Linguine again. Words with Wine was totally sold out. Barnes and Noble sold all but 5 of the "California Gold" books.

David Montgomery-Scott, Library and Recreation Services Director, will be receiving donations from the Day Family, Roybal Family, and the Spiegel Family.
