Action: Information and Discussion

Mr. Tom Moody, General Manager, introduced item to the Committee and provided background on the Mangular Park and the addition of a Booster Station.

Mr. Vernon Wiseman, District Engineer, presented the Committee with an update of the project. Mr. Wiseman provided a description of the proposed construction of a portable water booster pump that will be added next to the existing water tank at Mangular Park. Mr. Wiseman noted this will be one of two blending cells used by the Department of Water and Power to disinfect and run water throughout the water distribution system.

Council Member Jason Scott inquired about the existing tennis courts and if they plan on remaining open during construction. Staff responded that the tennis courts will remain open for most of the construction. Mr. Wiseman also noted that there will be off street vehicle access from Ontario Avenue. This will help keep the vehicles off the sidewalk and street.

Commissioner Jeff Ruscigno inquired about the noise level and impact to surrounding neighborhood. Mr. Wiseman noted that several neighborhood meets were held for public outreach. He provided the Committee with an overview of the neighborhood and environmental features. This will help reduce visual impact. The pump will be in a masonry block building with acoustical panels and vents for noise reduction.

Dan Jey, Resident, inquired the what the purpose of the facility was. Vice Mayor Eugene Montanez provided an overview that this facility will be used for disinfecting and pumping clean water to surrounding areas.

The Committee thanked staff for update.
