Overview and status of reliability of the electrical service for the Crossings At Corona and Dos Lagos area, and possible direction to staff regarding pursuing funding partnership options with SCE for improvements to SCE systems.

Tom Moody, Department of Water and Power General Manager, provided presentation. He discussed Electric Utility; Electric System Overview; Corona's Distribution; Southern California to City Distribution Lines; and Electric Utility Concerns Identified.

Jeremy Goldman, Government Relations Manager and Amy Olson, Key Accounts, Senior Advisor for Southern California Edison, introduced the Southern California Edison team. Bryon Watkins, Engineering Manager for Southern California Edison, provided presentation. He discussed Corona's Source Circuit; Southern California Edison Corona Department of Water and Power Partnership; Work Completed So Far; Prior Southern California Edison Work; After Southern California Upgrades; and Options for Corona.

Council Member Speake had inquiries regarding the presentation. Mr. Watkins provided clarification. Mr. Moody further discussed Current Options and Recommendation and Corona Department of Water and Power Domestic Rates. Council had inquiries regarding the current options. Mr. Moody and Mr. Watkins provided clarification.

Mark Hayest, resident, addressed the Council regarding his concerns with power outages and his contact with the Department of Water and Power.

Council agreed to move forward with option 2. Mr. Moody thanked the Council for their support and stated that the Department of Water and Power and Southern California Edison are working to minimize power outages. He also reported their next step. Mayor Scott provided instruction to Michele Nissen, Acting City Manager.
