## A. Council Member Yolanda Carrillo

## B. Council Member Jacque Casillas

Council Member Casillas provided an update on the joint meeting with Vice Mayor Steiner, Corona-Norco Unified School Board President Mary Ybarra and Board Member Bill Pollock. She stated that the meetings would be held on a bi-monthly basis. Council Member Casillas reported she attended the following events: the 19th Amendment anniversary event held at the Riverside Women's Club and Jess Hill Dedication at Corona High School. She provided an overview on both events.

## C. Council Member Wes Speake

Council Member Speake discussed the Regional Housing numbers and noted that Joanne Coletta, Community Development Director, submitted a letter to Southern California Association of Governments (SCAG) to express concerns with the methodology used in the assessment and also expressed his concerns with the Regional Housing requirements. Council Member Speake provided an update on the meeting held City staff and representatives from Southern California Edison. He reported that there will be a scheduled power shut off in the Dos Lagos area on September 22, 2019 and further information will be provided once the details have been confirmed. Council Member Speake reported that he attended the Jess Hill Dedication.

## D. Vice Mayor Jim Steiner

Vice Mayor Jim Steiner provided an overview on potential road improvements for the Green River and Serfas Club on-ramps. He noted that staff met with the California Department of Transportation (Caltrans) and Caltrans denied the proposed request by the City for the restriping of Serfas Club and the vehicle detection system on Green River. Vice Mayor Steiner requested that Public Works staff provide a presentation on the breakdown of the proposed request denied by Caltrans at the next City Council meeting. Vice Mayor Steiner also provided an update of the Green River on-ramp meter and requested that staff obtain data from Caltrans to show the significance of the impact on Green River.

## E. Mayor Jason Scott

Mayor Scott provided a detailed overview on a meeting held with the Vietnam Delegation to discuss possible financial investment opportunities in Corona. He noted that the following cities were also invited to participate in the meeting: Eastvale, Menifee, Moreno Valley, Perris and Riverside.

Mayor Scott reported that he attended the following meetings/events: UNITY meeting, Live on the Lawn hosted by Kids Rock, Elks Car Show, Cannabis Committee meeting, Jess Hill Dedication, Special Forces Sports Day meeting . He provided an overview on each event.
