Cynthia Lara, Administrative Services Manager II, introduced the item and Clint Whited, CDBG Consultant, provided a presentation. Mr. Whited provided an overview of the following: Resources, Community Development Block Grant (CDBG) Funds, HOME Investment Partnerships (HOME) Funds, Proposed Consolidated Plan Strategies, Affordable Housing, Community Facilities, Public Services, Infrastructure, CDBG Capital, CDBG Public Service, and Consolidated Plan Schedule.
