Overall, there were 48 participants for this event and some of the artwork created will be put on display in City Hall.

COVID Reopening Update

The Library is planning to discontinue the temporary COVID Rules of Conduct, remove distancing and directional set up at library entrance, remove distancing and directional signage throughout library and discontinue capacity limitations. The library will add signage reading, *PER CDC GUIDELINE, FACE MASK NO LONGER REQUIRED FOR FULLY VACCINATED INDIVIDUALS.*

The Senior Center and the Circle City Center (CCC) are opened now with limited capacity and will

transition to full capacity after August 1, 2021. These facilities will also add the same signage as the library.
